




#### **2009 Facts and Figures Incident Type**


The Fire District responded to 4,369 calls for help in 2009. Although this was a slight decrease as compared to the prior year, the district has experienced an annual increase of 3.5% in call volume over the past ten years.



An important activity in our emergency response planning is analyzing where our incidents occur. To accomplish this task, historical incident data is tracked and plotted onto a map in one square mile increments. This information in conjunction with other risk-assessment data is used to identify staffing and equipment requirements as well the effectiveness of our current and planned fire station locations. As this chart shows, the majority of our incident activity continues to occur in the downtown City of McHenry area.

Along with an understanding of where our incidents occur, it is also important to know when they occur. While our incident activity is consistent from day to day, there is a marked increase in volume between the hours of 7 a.m. and 6 p.m.





## Knox-Box<sup>®</sup> A Useful Firefighting Tool



#### What Is It?

A Knox Box, known officially as the Knox-Box Rapid Entry System is a small, wall-mounted safe that holds building keys for firefighters and EMTs to retrieve in emergencies. Local fire companies can hold master keys to all such boxes in their response area, so that they can quickly enter a building without having to force entry or find individual keys held in deposit at the station. Sometimes Knox Boxes are linked via radio to the dispatch station, where the dispatcher can release the keys with DTMF tones.

## 2009 Annual Report

I write this report for the final time as I have retired as Fire Chief on December 31, 2009 after 37 years of service to the District. Although I am still employed by the District as Business Manager replacing Vern Manke who retired after 14 years as Business Manager of the District. Vern's experience, dedication and foresight into modern business practices put the Fire District in excellent financial position.

We experience a slight decrease in call volume for the year: In 2009 we responded to 4,369 calls vs. 4,441 for 2008 which represents about 1.5% decrease in calls from the previous year.

At the end of 2008 we put our new 100' Ladder Truck into service. This Truck replaces a 25 year old Truck which was sold to Eagle River Wisconsin Fire Department during 2009. In addition, the District also took delivery of two new 2010 Pierce Fire Engines. These new engines replace two of our front line engines which were 15 years old. The older engines were sold to other departments. A 2009 new Ambulance was also placed into service. The district maintains five Advanced Life Support Ambulances to cover the district.

#### The Board of Trustees adopted a program

during the year whereas all members received a baseline physical. These physicals were given in accordance with the NFPA Standards for firefighters. This assures management that our employees are fit for the job.

The District employed a Communications Consulting Company to review and write specifications for a new radio system. This is in anticipation of the mandatory new standard that the FCC has enacted effective December 31, 2011, that all radios must be reprogrammed to narrow banding. The district will add a repeater system for better communications within the district. The project should be completed in mid-2010.

During the year, the District invited ISO (Insurance Service Office) to come into our district and reevaluate our Fire Protection Class. This testing took a week long on site testing plus several hours gathering and preparation of reports, training records and fire hydrant maintenance records. We received notification late in the year that our Protection Class was reduced from Class 4 to Class 3 for better than half of the District. These areas are generally areas with fire hydrants. If you live in an area of our district with fire hydrants, you may see a reduction in your commercial or homeowners insurance.

The District embarked on a campaign to reduce the expense of heating and lighting three of the fire stations. In the fall of the year two stations received new heating plants and three stations received new lighting. We applied for and were awarded a grant from the State of Illinois for our GREEN thinking. In addition to

the grant we have seen a reduction of approximately 20% in utility bills.

Continuing Education for a members remains a high priority for the District. During the year, we had five members complete Firefighter II Class at MCC and five of our EMT's completed the Paramedic Class and are Licensed Illinois Paramedics providing Advance Life Support care in



our ambulances. The District employed five new part-time employees during the year who will be taking Firefighting II Class in early 2010.

In cooperation with the

McHenry County 911 Board the District installed computers in all of its front line vehicles. These computers are designed to have the information on the location, nature and directions on how to get to emergency calls. This technology has improved efficiencies in response to calls and clear precise directions on the what to expect upon arrival of the incident.

Tony Huemann was hired as Full-time Deputy Chief during June. Tony was selected to become the seventh Fire Chief of the District on January 1, 2010. Chief Huemann started his career in the Fire Service as a volunteer with McHenry Fire District. He went on to be a career firefighter with the Mt. Prospect Fire Department retiring as Battalion Chief with 23 years of service.

## **Fire Prevention Bureau**

The year 2009 was another very busy year. It continues to be my goal to run this division with the utmost dedication and professionalism to ensure that McHenry Township residents can live in a fire and life safe environment.

In 2009 we had 32 structure fires in our own district. We, thankfully, suffered no fire fatalities in 2009.

Our Smoke Detector program continues by allowing people to call us anytime if they need assistance with installing an alarm or battery. It remains our philosophy that we will check, and/ or install an alarm or battery for anybody that needs one within McHenry Township Fire Protection District.

We continue to use our 4 experienced inspectors to inspect all the commercial occupancies including schools, churches, and multi family residences. They include: Mitch Czech, Tim Butler, Ryan Harding, and Tony Oliver. They all work under the direction of Captain Frank Graham. Together they continue to inspect our roughly 1,700 commercial occupancies to gain code compliance and cooperation to promote a fire safe environment. In addition, the bureau continues to do plan reviews on all new businesses that come into our district

Our Fire Investigative team continues to stay busy investigating the origin & cause of all structure fires. Our team features 14 investigators and 4 assistants. It is the goal of this team to fully and professionally investigate the origin & cause of all structure fires using all resources at our disposal. We work hand in hand with the City of McHenry Police, Johnsburg Police, McHenry County Sheriff's Department, and the Office of State Fire Marshal.

Public Education continues to be one of our busiest and most visible programs each year. We present this education throughout the year via station tours, block parties, safety trailer demonstrations, special events (Fiesta Days, Saufen Speil, Lakemoor Days, etc.), and many more activities too numerous to list. The public education division is supervised by coordinator Cindy Bertulis. Significant incidents for the year included 2 structure fires. The first fire occurred on January 17th, 2009. A multi-family apartment building caught on fire on the first floor. As a result, smoke filled the hallway and stairwell requiring about 20 residents needing to be rescued. Our initial Engine and Truck company were able to get all the people safely out. We then successfully extinguished the fire saving the structure.

The second significant fire occurred on February 9th, 2009 at a popular restaurant in town. Our fire investigators worked closely with the local police and State Fire Marshal to have 3 people arrested within 24 hours of the fire for arson. The building was a total loss.

# Summary: Open Burning of Landscape Waste Regulations

## McHenry County Public Health Ordinance Effective April 1, 2008 This Ordinance applies to all areas of McHenry County. If you live in a city with more stringent restrictions, the more restrictive rules apply.

#### **PROHIBITED AT ALL TIMES**

- S Burning of manure, garbage, construction debris, trash, etc. on any property in McHenry County.
- S Burning of landscape waste within 100' of a habitable structure (i.e. residence, school, etc).
- S Burning of landscape waste within 50' of a non-habitable structure (i.e. detached garage, barn, etc).

#### **RESTRICTIONS WHEN GREATER THAN 100'** FROM A HABITABLE STRUCTURE AND 50' FROM **A NON-HABITABLE STRUCTURE**

- Only landscape waste and only on the property where the landscape waste was generated
- Only during the months of April, May, October and November on weekends only
- Only between dawn and dusk
- Only when the winds are less than 10 mph
- Must be supervised by an individual at least 18 years of age
- A fire extinguisher, garden hose or water source must be available at the burning site

#### **ENFORCEMENT**

Any officer of the McHenry County Department of Health, law enforcement agency, fire department or fire protection district is authorized to enforce the provisions of this Ordinance.

#### 500' EXEMPTIONS

Burning of on-site generated landscape waste 500' or greater from a habitable structure is allowed:

1) During any month of the year 2) On any day of the week 3) At any time of the day

NOTE: All other prohibitions / restrictions apply.

#### OTHER EXEMPTIONS

- Recreational fires; not larger than 3'x 3'x 3', and excludes leaves, grass or shrubbery clippings
- Ceremonial fires (bonfires) larger than 3'x 3'x 3', and excludes leaves, grass or shrubbery clippings; permit required from McHenry County Department of Health
- Habitat Reclamation or Firefighter Training

Because of the employees of the McHenry Township Fire Protection District, this fire department is well respected and viewed as a leader in the industry in providing a full range of fiscally responsible fire and life safety services.

I also would like to thank the Board of Trustees; President Allen Miller, Secretary Robert Meyer, Treasurer Phillip Bartmann, Trustee Christopher Bennett and Trustee Mark Justen for their dedication, insight, guidance and ability to provide the employees of the McHenry Township Fire Protection District with the best clothing, bunker gear, apparatus and equipment.

In January of this year (2010) I was fortunate enough to become the new Fire Chief in the organization where I first started my fire service career back in 1983. I would like to highlight a few of the goals for the future of the McHenry Township Fire Protection District:

- Continue to provide emergency services with Paid-On-Premise (POP) personnel. Currently our emergency services personnel work 2 – 12 hour shifts with 13 part-time firefighters, paramedics, EMT-B's and a shift commander for each shift. Shift change is at 6 AM and 6PM.
- Increase daily training activities. The department goal is for each firefighter to complete at least 10 hours of training per month.
- Establish and maintain a daily physical fitness schedule. Each of the 4 stations is equipped with weight training and cardio vascular endurance equipment so personnel can maintain their strength and endurance.
- Continue to provide public safety education for the school children within our fire protection district.
- Continue to provide fire inspections and pre-plans of the buildings within the fire protection district.
- Continue to work with all of the communities within the fire protection district as partners to provide the needed emergency services to keep our residents safe.

I look forward to serving each of the residents of the McHenry Township Fire Protection District as the Fire Chief and I look forward to serving with all of the dedicated officers, firefighters, paramedics and EMT's of the McHenry Township Fire Protection District.

## McHenry Township Fire Protection District 2009 Training

- Total Training Hours for 2099 13,566 (Averages out to around 90 hours per firefighter)
- Truck Training The 100' Pierce Ladder Tower was delivered in 2008 and personnel continue to train on Truck Operations every month.
- Acquired Structure in June the McHenry Township Fire Protection District acquired a house scheduled for demolition in the fall. The two-story structure allowed fire department personnel to train on numerous topics.
- Proficiency Training and Examination For the first time in its history, the McHenry Township Fire Protection District required all personnel to complete proficiency training and to complete a practical examination on firefighting skills. All personnel completed training prior to the examination and then personnel completed and passed the examination.
- Engine Training In October of 2009 the McHenry Township Fire Protection District took delivery of 2 Pierce Fire Engines. Many hours of training had to be completed prior to placing both of those engines in service. There were numerous training topics covered for engine operations on Engine 10 and Engine 21.
